Check in time is 4pm. If you plan to arrive earlier, please contact us at info@kimberleycondos.com at least one week prior to your arrival, and we will do our best to have your check in ready early. We cannot accommodate early check in over Holiday Periods.

- Smoking of any kind is NOT allowed in the unit and evidence of such will result in a \$250 charge.
- People other than those in the Guest party may not stay overnight in the property. Any other person in the property is the sole responsibility of the Guest. Guests are not allowed to exceed the occupancy limit of the unit. 3. Guests should not create excessive noise at a level that disturbs neighbors from 8:00p.m. 8:00a.m.
- Check out time is 10:00 am on the day of departure.
- All of the units are privately owned; the owners are not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities. The Kimberley Lodging Co. Ltd. and Homeowners are not responsible for the loss of personal belongings or valuables of the guest. By accepting this reservation, it is agreed that all guests are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premise.
